



Ohio Board of Nursing (OBN) Approvers

January 2, 2019

An OBN Approver is an organization that is authorized by the Board to approve continuing education (CE) activities offered by a provider or to approve a provider unit. A provider of CE may work with any of the OBN Approvers when they plan to offer a CE activity.

If a provider plans to offer CE known as Category A,¹ the CE activity must be approved by an OBN Approver or offered by a provider unit that is headquartered in the state of Ohio and has been approved by an OBN Approver. Please refer to Chapter 4723-14, OAC, for the administrative rules regarding CE.
